Alan Lamb is the supervisor of the South County Adult Mental Health Team. He is responsible for the clinical services for persons with serious mental illness, often with co-morbid issues of substance abuse, physical illness, and other psychosocial stressors, such as homelessness.

Alan is passionate and dedicated in delivering quality services to the community. He works closely with community based agencies, including residential settings and hospitals, in efforts to offer consumers the best coordinated service delivery.

He supervises mental health case managers, two therapists, and offers them tremendous support. He oversees the administrative aspects of their work, but he is also acutely aware of all of the clients his staff serve, and offers insights and suggestions for care. He is supportive of his staff, is helpful to the medical staff, to the clinic staff, and often is called upon to address site/facility issues. Additionally, he is "hands on", helping his staff's clinical case load by providing some direct services.

He is a tremendous advocate for staff in getting their needs met to do the job. One of his strengths is the ability to name system issues that interfere with quality care and staff productivity. He brings these issues to the attention of management staff, including his supervisor, in efforts to seek solutions.

Alan is the hardest working clinical supervisor in the agency. He is constantly busy! He keeps close watch of clinical care of clients, tracks clinical documentation, and faces work site challenges head on, in efforts to find either solutions or "work arounds". (An example of this are his efforts of understanding and using the new electronic medical record system, a system that everyone in the agency is struggling with.)

His dedication to the clients, the community, and his outstanding support of his team of clinicians has earned
