New Substance Use Disorder Services Director!

We are pleased to announce that after a very extensive recruitment and interview process, we have selected **Shaina Zura** as Santa Cruz County's new Substance Use Disorder Services Director. Shaina is currently the Managing Director of San Diego County for HealthRIGHT 360, where she provides executive leadership for all HealthRIGHT 360 management teams in San Diego County providing substance use disorder treatment, mental health services, early childhood education, perinatal services and transitional housing.

In her current position she has worked very closely with the County of San Diego in their implementation of the Drug Medi-Cal ODS waiver and has extensive experience in strategic planning, improvement quality and stakeholder engagement. Prior positions with HealthRIGHT 360 include: Director of Female Offender Treatment and Employment Program, Director of Outpatient Services, Methamphetamine Program Manager, and Case Manager and Therapist. Ms. Zura joined the County on June 1st, and her initial responsibilities will include implementation of the Drug Medi-Cal expansion program, integrating mental health and substance use disorder treatment programs, and continued focus on the implementation of the Substance Use Disorder Strategic Plan.
