Richard Gallo – 1) SB65 State Legislation bill which would allow MHSA funding to be used for jails did not pass, which is good news. 2) As the Coronavirus pandemic continues, more people rely on USPS to receive medications through mail-order pharmacies. USPS has been experiencing major delays in mail service for the needs of seniors and people with disabilities. The National Council on Independent Living and the American Association of People with Disabilities is requesting feedback from community who have experienced delays in receiving medications, medical supplies, basic necessities, paychecks, bills, etc.
