The data shows the trend of litter in different areas. The Extra Help Mental Health Client Specialist is working on follow-up, outreach activities and SUD treatment navigation. August is Overdose Awareness Month.

  have not accessed program in years

- Last Thursday shift at Watsonville Health Center will be 9/14/23
