Interim Guidance for Long Term Care and Skilled Nursing Facilities in Santa Cruz County

<u>Prevent introduction</u> of respiratory germs INTO your facility

- Post signs at the entrance instructing visitors not to visit if they have symptoms of respiratory infection.
- Ensure sick leave policies allow employees to stay home if they have symptoms of respiratory infection.
- Upon admission, assess residents symptoms of respiratory infection and implement appropriate infection prevention practices for incoming symptomatic residents.

Prevent spread of respiratory germs WITHIN your facility

Keep residents and employees informed- This helps to reassure and calm.

- Post visual alerts (signs & posters) at entrances and in strategic places providing instruction on hand & respiratory hygiene.
- Monitor local and state public health resources to understand COVID-19 activity in your community.
- Discuss stigma with your employees.

Monitor residents and employees for fever or respiratory symptoms.

- Consider limiting visitors to the facility.
- Observe newly arriving patients for development of respiratory symptoms.
- In general, for care of residents with undiagnosed respiratory infection use Standard, Contact, and Droplet Precautions with eye protection unless suspected diagnosis requires Airborne Precautions (e.g., tuberculosis).

Take steps to prevent known or suspected COVID-19 patients from exposing other patients.

- Limit the movement of COVID-19 patients (e.g., have them remain in their room).
- Identify dedicated employees to care for COVID-19 patients and provide infection control training.

Support hand and respiratory hygiene, as well as cough etiquette by residents, visitors, and employees.

- Ensure supplies are available (tissues, waste receptacles, alcohol-based hand sanitizer) and correct use of PPE.
 - * Post signs on the door or wall outside of the resident room that clearly describe the type of precautions needed and required PPE.
 - * Make PPE, including face masks, eye protection, gowns, and gloves, available immediately outside of the resident room.
 - * Position a trash can near the exit inside any resident room to make it easy for employees to discard PPE.
- Ensure employees clean their hands according to CDC guidelines, including before and after contact with residents, after contact with contaminated surfaces or equipment, and after removing personal protective equipment (PPE).

- Put alcohol-based hand rub in every resident room (ideally both inside and outside of the room), and make sure tissues are available and any sink is well-stocked with soap and paper towels for hand washing.

- Dedicated medical equipment should be used for patient care.
- All non-dedicated, non-disposable medical equipment used for patient care should be cleaned and disinfected according to manufacturer's instructions and facility policies.
- Ensure that environmental cleaning and disinfection procedures are followed consistently and correctly.

<u>Prevent spread</u> of respiratory germs **BETWEEN** facilities

- **Notify** facilities prior to transferring a resident with an acute respiratory illness, including suspected or confirmed COVID-19, to a higher level of care.
- **Report** any possible COVID-19 illness in residents and employees to the local health department at (831) 454-4114.

Key Considerations for Healthcare Facilities:

Currently there are no medications to treat or vaccines to prevent COVID-19. Community approaches to slowing transmission are needed to reduce the number of people who get sick.

In each healthcare facility, the primary goals are to:

- Prepare for a potential surge in patients with respiratory infection
- Protect healthcare personnel and non -COVID-19 patients accessing healthcare from infection
- Provide appropriate levels of care
- Prepare for shortages in personal protective equipment supply and staff
