EMERGENCY MEDICAL CARE COMMISSION

ITEM:

- Call to Order at 9:00am and a Quorum was established.
- 2. Review/Correct Agenda All OK.
- 3. Minutes for February 13, 2022 Item 6 Commissioners are concerned that proposed radio system appears to be inadequate and are seeking more information regarding the RFP. Would like Tammie Weigl to present again on status of RFP.
 - Flood Response After Action Report to be on next month's agenda. Minutes approved by Commission Nee making the motion and Commission McGannon seconded, vote agreed.
- 4. Written Correspondence None.
- 5. Oral Communications
 - a. County employee Laurel Gazza discussed Brown Act Agendas and how the EMCC will be moving to agenda packets which include presentations and documents that will be included with the agenda. Suggested Agenda Planning Meetings with EMCC for the following month's agenda items. AB2449 states Commissioners must attend in person to vote and establish quorum.
 - b. Dr. Ghilarducci brought up meeting cadence suggesting monthly may be too much. Laurel said a lot of public meetings are held quarterly. Will add to the April agenda.
 - c. Greg Benson would like to add Field Care and AMR Commissioner nominations to the April Agenda.
 - Need another co-chair to replace Dan Quinto. Commissioner Nee volunteered, Commissioner Schambach made the motion, Commissioner Benedict seconded, vote agreed.
 - e. EMS Week is May 21-27. Add to the April agenda.
- 6. Pediatric Behavioral Health Crisis Stabilization Program Tiffany Cantrell-Warren, Director County Behavioral Health and James Russell, Director Access and Crisis Services. CSP is phasing out youth effective 3/27/23. There is a hail-Mary meeting next week to keep CSP open to youth through June. Depends on staffing/patient ratios. Long term fix is new facility by the Sheriff's office, however, will not be completed until end of 2024. See the attached presentation. Would like an update at the next EMCC meeting will add to the April Agenda.
- 7. Stroke Care Information, Carly Newbold, Dominican Hospital Please see the attached presentation.
- 8. Program Updates
 - a. Covid and Flu Updates and Prehospital Advisory Committee, Dr. Ghilarducci Cases are stable. April 3 will see mask requirements

lifted. ImageTrend 3.5 scheduled for October 1. Training for all staff will be done and testing is currently being done on the Central Coast only. Ketamine use as an analgesic alternative will be added this summer. Critical care transport paramedic for the County, Dr. Ghilarducci and Greg to talk more about this. Hazel Hawkins update 8 parties possibly interested in purchasing the hospital. If it closes, that will add 12 miles to transport patients and will need 2 additional ambulances. 25 hospitals are in the same position as Hazel Hawkins due to staffing and medi-cal payments. Hazel Hawkins does not qualify for emergency help and the help would just be temporary.

- b. EMS Administrator Report, Greg Benson AMR's numbers & compliance caught up through 2022. On schedule for 2023. Storm challenges with EOC communication that went out telling everyone to stay home unless absolutely necessary made for huge staffing issues for the hospitals and AMR. There was no Hwy 1 road closure information sent out prior to closing Hwy 1 in South County. The National Guard pre-positioned a Blackhawk helicopter in Monterey County in case Hwy 17 closed.
- c. ET3 and Innovator Report No report.
- 9. Radio Communications Concerns Discussion Current upgrades to communication system did help LEO but not much help to ambulances. No clear solution study done, need more input. Projected options can't handle system, trunk system limited in emergencies, number of available options presented were not helpful, need more repeater sites. Fire has concerns about how the County is handling this. Would like to see the RFP presented to the EMCC.



Critical Issues – CSP and Youth CSP was phasing out youth as of March 27, now extending to June 30


History of youth receiving

Dear Partners,

As discussed in the Crisis Continuum Group on 3/22/23, Telecare has agreed to extend the period they will continue accepting youth at the Santa Cruz CSP site through June 30, 2023. During this time, youth and adults will continue to be accepted based on bed and staffing availability. If the CSP is Code Red for either adults or youth, current practices will continue with diversion to the local emergency department. With regards to youth placed on a 5585 hold, please note that until June 30, 2023, there will be no change in the designated receiving center, you will continue to write in "Santa Cruz County Behavioral Health Unit 2250 Soquel Ave., Santa Cruz."

County Behavioral Health (BH) acknowledges the difficulty this decision poses for the Telecare team as they were planning to focus their efforts and logistics solely on adults. We also want to acknowledge the improvements that Telecare, in cooperation with all our partners, has made in their service provision. As a result of that dedication to improvement, the CSP percentage of hours on code red has decreased from 91% to 67% (for youth) and from 47% to 11% (for adults).

As a community, we will continue to make every effort to find alternatives to placing a youth on a 5585 hold where safe alternatives exist. For youth in the community experiencing a behavioral health crisis, and who can be safely transported by Parents/Guardian/Caregivers, County BH Children's ACCESS offers walk in crisis support at both our Santa Cruz and Watsonville clinics during business hours from 8:30 AM to 4:30 PM Monday through Friday. MERTY will provide crisis deescalation, assessment, and safety planning at secure locations in the community (schools, program sites, etc.) as well as back up to Children's ACCESS Team.

County BH recognizes the strain on all our community partners providing services and especially the youth and their families who experience behavioral health crises during these changes. In addressing services related to youth in crisis and placed on 5585 holds, County BH is taking the following steps to mitigate the impact.

Immediate:

- 1. MERTY staff will respond to emergency departments to evaluate to see if patient can engage in safety planning with caregivers to lift the hold.
- 2. County BH is seeking to contract with a Santa Clara based CSP to have priority placement from our emergency departments, dependent on bed space. This would continue to necessitate a non-EMS ambulance service to transport.

Intermediate:

- 1. County BH is in negotiations with Watsonville Community Hospital to open a temporary CSP for youth in the Fall of 2023. This will be a four-chair receiving center.
- 2. County BH is in negotiations with a contract provider to provide CSP services for youth in the above space.

Long-term:

- 1. The County of Santa Cruz is in escrow to purchase the remaining buildings at 5300 Soquel Ave., Santa Cruz. Planning has begun on the construction of a new Youth CSP and Crisis Residential Program at the location.
- 2. The projected date of the program opening is the end of 2024/early 2025.
- 3. The addition of this facility will mean 8 beds dedicated as a Youth CSP and an additional 16 beds dedicated for a Youth Crisis Residential facility.

We will continue to provide regular updates as changes and improvements are made in the provision of services related to the youth receiving center needs. If you have any additional questions, concerns, or suggestions, please direct them to james.russell@santacruzcounty.us
